MANAGEMENT DISCUSSION AND ANALYSIS

1. Industry structure and developments

Deferred Tax expenses & credit & related liabilities or assets are recognized for tax consequences attributable to the differences between accounting profit and taxable income. Deferred Tax Assets are only recognized if there is reasonable certainty that they will be realized, in terms of para 15 read with the para 17 of the said Accounting Standard. These assets are reviewed for appropriateness of their carrying amount at each Balance Sheet date. Deferred Tax Assets & liabilities are measured using the tax rates that have been enacted or substantively enacted at the Balance Sheet date.

c) . Earnings Per Share (EPS)

Basic earnings per share are calculated by dividing the net profit or loss for the period attributable to equity shareholders (after deducting preferences dividend and attributable taxes) by the weighted average number of equity shares outstanding during the period.
