## Subject: Adjustment of Futures and Options contracts in the security BPCL

To All Members,

In terms of provisions of the Rules, Bye-Laws and Regulations of the Exchange, members of the Exchange are hereby informed that Bharat Petroleum Corporation Limited (BPCL) has fixed Record Date as July 15, 2017 for the purpose of issue of Fully Paid Bonus Shares in the ratio of 1:2 i.e. (One) Bonus Equity Share of Rs.10 Each for every 2 (two) existing equity shares of Rs.10 each

In view of the above and in compliance with the SEBI guidelines, the Exchange will make the necessary adjustments for all the available Futures & Options contracts on the security BPCL w.e.f. July 13, 2017, being the Ex-date. The adjustments to be made on account of the above corporate action are given below:

#### Adjustment factor:

Adjustment factor for Bonus issue of A:B is defined as (A+B)/B. As the bonus issue ratio of BPCL is 1:2, the adjustment factor is (1+2)/2 = 1.5

#### Adjustments for Futures & Option Contracts:

- 1. Futures price: Adjusted futures price =  $\frac{Old Future price}{Adjustment factor}$
- 2. Options Strike Price: Adjusted strike price =  $\frac{Old Strike price}{Adjustment factor}$
- Market Lot: Adjusted Market Lot size = Old market lot size x Adjustment factor = 1200 x 1.5= 1800.
- Open Position: Adjusted Position = Old position x Adjustment factor.

The above changes will be effective from July 13, 2017. Members are requested to take note of the same.
