Subject: Graded Surveillance Measure (GSM) – Updated list of companies

To All Members,

This is in continuation to the exchange circular no. MSEI/SURV/4942/2017 dated February 23, 2017 regarding introduction of Graded Surveillance Measure (GSM) framework as an additional surveillance measure

As per the provisions of the aforementioned circular, review for identification of securities for placing in GSM framework has been carried out and

- a) Securities given in **Annexure I** have been identified for placing in GSM Framework and monitoring of these securities for action shall be initiated from July 03, 2017.
- b) Securities given in **Annexure II** shall continue to remain in GSM framework with their applicable stages.
- c) Securities given in **Annexure III** shall move out of GSM Framework from June 27, 2017.

Market participants may note that GSM framework will be in conjunction with all other prevailing surveillance measures being imposed by the Exchanges from time to time. Further, the amount of Additional Surveillance Deposit (ASD) collected on securities given in Annexure III will be released on July 03, 2017.

Members are advised to exercise additional due diligence while trading in these securities either on own account or on behalf of their clients.
