Amendment to Circular 1787 - Testing of software used in or related to Trading and Risk Management

To All Members,

As a part of Exchange's constant efforts to provide value to market participants and on the basis of feedback received from market participants, the Exchange has decided to revise the POP connectivity to MPLS and timings for ISVs, ISVOI and In-House Members (members who are desirous of developing In-House CTCL software or developing / procuring CTCL software from non-empanelled vendor).

Members may please note that the POP connectivity is been migrated to MPLS (Multi-Protocol Label Switching) for ISVs, ISVOIs and In-House Members for each segment. In view of the above, **Point No.6 (Test Environment Facility)** of circular no. MCX-SX/CTCL/1787/2014 dated February 25, 2014 on Testing of software used in or related to Trading and Risk Management is being amended as follows:

1. Para.6.2 shall read as follows:

ISVs/ISVOIs/Members can opt for Leased Line (MPLS) for connecting to Exchange provided CTCL test environment. Interested ISVs/ISVOIs/Members can apply to the Exchange by submitting an application (**Annexure 34** of circular: MSEI/CTCL/3926/2016 dated 4th March 2016) [format of Annexure 34 is attached herewith].

2. Para 6.3 shall read as follows:

6.3.1 Leased Line (MPLS) connectivity:

- a) Leased Line (MPLS) Connectivity
- b) Cisco router minimum 1900 or above series
