Subject: Adjustment of Futures and Options contracts in the security Bharat Electronics Limited (BEL)

To All Members,

In terms of provisions of the Rules, Bye-Laws and Regulations of the Exchange, members of the Exchange are hereby informed that Bharat Electronics Limited (BEL) has fixed Record Date as September 29, 2017 for the purpose of allotment of Bonus Shares in the ratio 1:10, i.e. one equity share for every ten equity shares held.

In view of the above and in compliance with the SEBI guidelines, the Exchange will make necessary adjustments for all the available Futures & Options contracts in the security BEL w.e.f. September 28, 2017, being the Ex-date. The adjustments to be made on account of the above corporate action are given below:

Adjustment factor:

Adjustment factor for Bonus issue of A:B is defined as (A+B)/B. As the bonus issue ratio of BEL is 1:10, the adjustment factor is (1+10)/10 = 1.1

Adjustments for Futures & Option Contracts:

1. Futures price:

Adjusted futures price = $\frac{\text{Old Future price}}{\text{Adjustment factor}}$

2. Options Strike Price:

Adjusted strike price = $\frac{\text{Old Strike price}}{\text{Adjustment factor}}$

3. Market Lot:

Adjusted Market Lot size = Old market lot size x Adjustment factor = 4500x1.1= 4950.

4. Open Position:

Adjusted Position = Old position x Adjustment factor.

The above changes will be effective from September 28, 2017. Members are requested to take note of the same.
