Subject: Adjustment of Futures and Options contracts in the security Tata Consultancy Services Limited (TCS)

To All Members,

In terms of provisions of the Rules, Bye-Laws and Regulations of the Exchange, members of the Exchange are hereby informed that Tata Consultancy Services Limited (TCS) has fixed Record Date as June 02, 2018 for the purpose of allotment of Bonus Shares in the proportion of 1 (One) Bonus Equity Share, for every 1(One) existing Equity Share.

In view of the above and in compliance with the SEBI guidelines, the Exchange will make necessary adjustments for all the available Futures & Options contracts in the security TCS w.e.f. May 31, 2018, being the Ex-date. The adjustments to be made on account of the above corporate action are given below:

Adjustment factor:

Adjustment factor for Bonus issue of A:B is defined as (A+B)/B. As the bonus issue ratio of TCS is 1:1, the adjustment factor is (1+1)/1 = 2

Adjustments for Futures & Option Contracts:

- Futures price: Adjusted futures price = <u>Old Future price</u> <u>Adjustment factor</u>
- Options Strike Price:
 Adjusted strike price = Old Strike price Adjustment factor
- Market Lot: Adjusted Market Lot size = Old market lot size x Adjustment factor = 250x2= 500.
- Open Position: Adjusted Position = Old position x Adjustment factor.

The above changes will be effective from May 31, 2018. Members are requested to take note of the same.
