**Live Re-login Activity:**

Particulars	Timings
Live Re-login Start Time	16:00 hrs
Live Re-login Close Time	16:30 hrs

Members may kindly note that those members who have established connectivity through VSAT, COLO or NPN with POP (as per Circular No: MCX-SX/IT/880/2012 dated November 1, 2012 and Circular No: MCX-SX/IT/904/2012 dated December 4, 2012) will be able to participate in Mock trading from the DR site. All TWS users who are connected through internet, may participate using internet connectivity.

Members may note that the trades resulting from such mock trading will not attract any margin obligation, pay-in and pay-out and do not create any rights and liability on members.

Procedure for downloading the files for participating in mock trading is specified in Annexure 1.

Procedure for Steps for logging in for participating in Mock for Reporting Platform is specified in Annexure 2.

Members are requested to re-login into live environment to check the connectivity and to avoid login problems on Monday, February 11, 2019.

## Annexure 1

### Steps for downloading files for participating in mock trading for Debt Market Segment.

a) Participants are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and password as being used in the live environment.

#### b) For Internet, Lease Line & VSAT users

- Download all the files kept in the **FIMCommon\Setup\Mock Setup** folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through VSAT/Lease Line and <https://sftp.msei.in> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through VSAT / Leased Line on Friday, February 08, 2019 after trading hours.
- **Install VC++Redistributable 2008 on the system.**
- **Install Microsoft Visual J# 2.0 Redistributable package-SE on the system.**
- **Install dotnetfx45\_full\_x86\_x64 on the system.**
- **Execute SXFIRST.BAT (Leased Line and VSAT Users ONLY)**
- Double click **MSEFIMTWS11.msi** It will install the **MSE-FIM Trader Workstation TEST** for mock Trading Version 11.6.16

After installation, open **MSE-FIM Trader Workstation TEST** and follow below mentioned step:

- Go to Tools → System configuration
  - Select Mode of Connectivity as “Internet” if connecting through internet and “Dedicated” if connecting through Lease Line
  - If Mode of Connectivity is selected as “Dedicated” select Market Data Updates as “Normal”
  - After selection click on Modify
  - System will set the Mode of Connectivity and Market Data Updates settings automatically and application will get closed
  - Start **MSE-FIM Trader Workstation TEST** and login to the mock trading environment.
- Double click **MSEFIMMEMADMIN11.msi** It will install new MSE-FIM Member Administrator for mock Trading Version 11.6.16

After installation, open **MSE-FIM Member Admin TEST** and follow below mentioned step:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Dedicated**”
- Select Market Data Updates as “**Normal**”
- After selection click on Modify
- System will set the Mode of Connectivity and Market Data Updates settings automatically and application will get closed
- Start MSE Member Administrator Test and login to the mock environment of MSE
- Start MSE- FIM Member Admin Test and login to the mock trading environment.
