Normal Market close time for Cross Currency Derivatives	14:30 hrs
Trade modification end time	14:40 hrs

Members may note that the trades resulting from such mock trading will not attract any obligation in terms of funds and/or securities, pay-in and/or pay-out, and do not create any rights and liability on members. MyExchange facility will not be available during mock trading and same would be available after live re-login session.

Annexure

Steps for downloading files for participating in Currency Derivatives Mock Trading:

- a) Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and default password as being used in the live environment.

Download the files kept in the COMMON\SETUP\MOCK Setup folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.msei.com> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday, June 14, 2019 after trading hours.

- b) Install VC++Redistributable 2008 on the system.
- c) Member opting to connect using THRU are required to refer to the **Mock THRU** Installation Guide kept on the COMMON \SETUP\MOCK Setup folder in the SFTP (Extranet) Server.
- Members are required to communicate THRU machine IP address to the Exchange on customerservice@msei.in along with User IDs / MAT IDs details connecting through particular THRU machine. Mail subject should be "MOCK-THRU Connection detail-Currency Derivatives Segment"
 - The details to be provided in following format. The details should be provided latest by 06.00 pm – Friday June 14, 2019.

Sr. No.	Member ID	Segment	THRU Machine IP Address (as provided in Exchange Network Interface in THRU configuration)	User IDs / MAT IDs connecting through particular THRU machine (in Single line comma separated)

- d) Double click **MSE-CDSMEMADMIN.msi**. It will install the MSE Trader Workstation TEST for mock Trading Version 11.6.16.
- e) Double click **MSE-CDSTWSCLIENT.msi**. It will install new MSE Member Administrator TEST for mock Trading Version 11.6.16.
- f) Following steps are to be followed by Members after installation of TWS / MAT

i. For Leased Line mode of connectivity

After installation start TWS / MAT and follow below mentioned steps:

- Go to Tools → System configuration
- Member using THRU needs to select "THRU" in Mode of Connectivity. Other members need to select "Dedicated".
- Select Market Data Updates as "Normal".
- If Member is using THRU, enter THRU machine IP address in "Host IP Address" under Interactive settings. THRU machine IP address is same as entered in THRU configuration – "Client Network Interface"
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the mock environment of MSE Currency Derivatives.

ii. Internet users:

SSL VPN URL for MOCK: - <https://trading.msei.in>

After installation start TWS and follow below mentioned steps:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the mock environment of MSE Currency Derivatives.
