Subject: Adjustment of Futures and Options Contracts in security RECLTD

To All Members,

In terms of provisions of the Rules, Bye-Laws and Regulations of the Exchange, members of the Exchange are hereby informed that the Board of Directors of REC Limited at their meeting held on February 28, 2019, have declared special Interim dividend of Rs.11 per equity share. The record date for the purpose of payment of dividend is March 12, 2019.

In pursuance of SEBI guidelines for adjustments to futures and options contracts on announcement of extraordinary dividend (i.e. over 5% of the market price of the underlying stock), decision of SEBI Advisory committee on derivatives, and in line with the SEBI Master circular No SEBI/HO/MRD/CIR/P/2016/135 dated December 16, 2016, and MSE Circular No: MSE/TRD/6535/2018 dated July 9, 2018, members of the Exchange are informed of the adjustment of the derivatives contracts in the security RECLTD w.e.f. March 11, 2019, being the Ex-date as below:

Adjustments for Futures Contracts:

Base price of the Futures contracts on March 11, 2019 will be reference rate less aggregate amount of dividend i.e. Rs.11/-. The reference rate will be the daily settlement price of the relevant futures contract.

Adjustments for Options Contracts:

The full value of dividend i.e. Rs.11/- will be deducted from all the cum-dividend strike prices on the exdividend date.
