SEBI order in respect of Jayesh Kanungo in the matter of Grandma Trading and Agencies Limited

To All Members,

SEBI vide order no. WTM/MPB/EFD1-DRA4/31/2019 dated March 26, 2019, has restrained Mr. Jayesh Kanungo (PAN: AABPK7808F) from accessing the securities market for a period of two years from the date of this order and further prohibited him from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of two years, from the date of this order. In view of prohibition on sale of securities, it is clarified that during the period of restraint, the existing holding, including units of mutual funds, of the Noticee shall remain frozen.

The order shall come into force with immediate effect.
