SEBI order in respect of Ms. Anjana Arun Karwa in the matter of Shree Shaleen Textiles Limited (SSTL)

To All Members,

SEBI vide order no. WTM/MPB/EFD1-DRA4/30/2019 dated March 26, 2019, has restrained Ms. Anjana Arun Karwa (PAN: AHQPK9496D) from accessing the securities market for a period of four years from the date of this order and further prohibited her from buying, selling or otherwise dealing in securities, directly or indirectly, or being associated with the securities market in any manner, whatsoever, for a period of four years, from the date of this order. In view of prohibition on sale of securities, it is clarified that during the period of restraint, the existing holding, including units of mutual funds, of the Noticee shall remain frozen.

The order shall come into force with immediate effect.
