Subject: Suspension of Trading for non-compliance Regulation 33 of SEBI LODR Regulations, 2015

To All Members,

Pursuant to the provisions of Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (erstwhile SEBI/HO/CFD/CMD/CIR/P/2018/77 dated May 03, 2018) issued by Securities and Exchange Board of India ("**SEBI**") with respect to Standard Operating Procedure ("**SOP**") for suspension and revocation of equity shares of listed entities for non-compliance pursuant to the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**"); it is hereby informed that the below mentioned Companies have been identified as Non-compliant with Regulation 33 (i.e., Submission of Financial Results) for two consecutive quarters' i.e. March 2023 & June 2023.

Therefore, the trading in securities of the said companies are eligible for suspension (except companies which are under IBC), however, Exchange has initiated action on these companies for various non-compliances of Listing Regulations. The Circulars details of which are as under:
