## Subject: Shifting to "BZ" Series - Non-compliant with Regulation 31

## To All Members,

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (erstwhile SEBI/HO/CFD/CMD/CIR/P/2018/77 dated May 03, 2018), members of the Exchange are hereby informed that the below mentioned Companies have been identified as Non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") for two consecutive quarters' i.e. March 2023 & June 2023. This circular shall be effective from September 22, 2023.
