Subject: Dividend: Adjustment of Futures and Options contracts in the security GUJRAT NARMADA VALLEY FERTILIZERS AND CHEMICALS (GNFC)

To All Members,

In terms of provisions of the Rules, Bye-Laws, Regulations and SEBI Master Circular no. SEBI/HO/MRD/DP/CIR/P/2016/135 dated December 16, 2016, SEBI circular no. CIR/MRD/DoP-1/P/00108/2018 dated July 5, 2018 and SEBI/HO/MRD2/MRD2_DCAP/P/CIR/2022/90 dated June 28, 2022; members of the Exchange are hereby informed that the Board of Directors of GUJRAT NARMADA VALLEY FERTILIZERS AND CHEMICALS have declared Final Dividend of Rs. 30/- per equity share of face value of Rs. 10/- each. The adjustment of the derivatives contracts in GNFC will be w.e.f. September 18, 2023 being the ex-date.

Adjustments for Futures Contracts:

Base price of the Futures contracts on September 18, 2023 will be reference rate less aggregate amount of final dividend of Rs. 30/- The reference rate to be reckoned for this purpose shall be the daily mark to market settlement price of the relevant futures contract.

Adjustments for Options Contracts:

The full value of final dividend i.e. Rs. 30/- would be deducted from all the cum-dividend strike prices on the ex-dividend date.

The revised options strike/futures base prices on account of adjustment would appear in decimal places and shall be rounded off to the nearest tick size and the lot size shall be rounded off to the nearest integer.
