Subject: RIGHTS Adjustment of Futures and Options contracts in the security ADANI ENTERPRISES LIMITED (ADANIENT).

To All Members,

In terms of provisions of the Rules, Bye-Laws and Regulations of the Exchange, members of the Exchange are hereby informed that, ADANI ENTERPRISES LIMITED (ADANIENT) has approved to issue equity shares on rights basis in the ratio of 3:25, i.e. 3 Equity Shares for every 25 Equity Shares held at an issue price of Rs. 1800 per equity share.

Adjusted futures price = Old Future price x Adjustment Factor
2. Options Strike Price:
Adjusted strike price = Old Strike price x Adjustment Factor

3. Market Lot:

$$\text{Adjusted Market Lot size} = \frac{\text{Old Market Lot Size}}{\text{Adjustment Factor}}$$

The revised options strike/futures base prices on account of adjustment would appear in decimal places and shall be rounded off to the nearest tick size and the adjusted lot size shall be rounded off to the nearest integer.
