<u>Subject: Suspension of Trading for non-compliance of regulation 76 of SEBI (Depositories & Participants)</u>
<u>Regulations, 2018 - Nawratan Arts Limited</u>

To All Members,

Pursuant to the provisions of Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (erstwhile SEBI/HO/CFD/CMD/CIR/P/2018/77 dated May 03, 2018) issued by Securities and Exchange Board of India ("SEBI") with respect to Standard Operating Procedure ("SOP") for suspension and revocation of equity shares of listed entities for non-compliance pursuant to the provisions of SEBI (Depositories & Participants) Regulations, 2018; it is hereby informed that trading in equity shares of below mentioned company will be suspended w.e.f November 20, 2025 (being 31 days from issue of this notice); on account of non-compliance with Reg. 76 of SEBI (Depositories & Participants) Regulations 2018, for two consecutive quarters i.e. March 2025 & June 2025:

Further, Freezing of the entire shareholding of the promoter in the non-compliant listed entity as well as all other securities held in the demat account(s) of the promoter shall remain frozen during the period of suspension.

In case, the above mentioned company comply with all the provisions of the SEBI (Depositories & Participants) Regulations 2018, on or before **November 17, 2025** (to the satisfaction of the Exchange), then trading in equity shares of the said companies will not be suspended.

However, in case the aforesaid company fail to comply with the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as mentioned above on or before **November 17, 2025,** then:

- Trading in the equity shares of the company would be suspended w.e.f. **November 20, 2025**, and the suspension will continue till such time the companies comply.
- 15 days after suspension has been effected, trading in the shares of non-compliant company would be allowed on Trade for Trade basis in (Series "BZ") on the first trading day of every week for six months.



• Revocation of suspension would be subject to the company further complying with the procedure and all existing norms prescribed for revocation of suspension.
