To All Members,

In terms of provisions of the Rules, Bye-Laws & Regulations of the Exchange members may please note that Exchange will be conducting Mock session in Currency Derivatives on Saturday, February 14, 2026, as per the following schedule:

**Schedule for Mock Trading Session:**

Particulars	Time
Log-in time	<b>10:15 hrs onwards</b>
Normal Market open time	<b>11:00 hrs</b>
Normal Market close time	<b>15:30 hrs</b>
Trade modification end time	<b>15:40 hrs</b>

**Exchange will be performing intraday switchover from DC to DR during the Mock trading session.**

The procedure for downloading the files for participating in mock trading is specified in Annexure.

Members may note that the trades resulting from such mock trading will not attract any margin obligation, pay-in and pay-out and do not create any rights and liability on members. Members are requested to participate actively in the Mock Trading Session.

**Members with approved algorithmic software should take part in at least one mock trading session each month using all User IDs approved for Algo trading.**

Steps for downloading files for participating in Currency Derivatives Mock Trading:

**a)** Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and default password as being used in the live environment.

Download the files kept in the COMMON\SETUP\MOCK Setup\Version 11.6.19 in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.msei.in> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday, February 13, 2026 after trading hours.

**b)** Install VC++Redistributable 2008 on the system.

**c)** Double click **MSE-CDSTWSCLIENT.msi**. It will install the MSE Trader Workstation TEST for mock Trading Version 11.6.24

**d)** Double click **MSE-CDSMEMADMIN.msi**. It will install new MSE Member Administrator TEST for mock Trading Version 11.6.24

**e)** Following steps are to be followed by Members after installation of TWS / MAT

**i. For Leased Line mode of connectivity**

After installation start TWS / MAT and follow below mentioned steps:

- Go to Tools → System configuration
- Select Market Data Updates as “**Normal**”.
- Members having bandwidth 2mbps or above needs to select Market Data Updates as “**HIGH**”. Other members need to select “**Normal**”
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the mock environment of MSE Currency Derivatives.

**ii. Internet users:**

**SSL VPN URL for MOCK: - <https://trading.msei.in>**

After installation start TWS and follow below mentioned steps:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the mock environment of MSE Currency Derivatives
