**Members with approved algorithmic software should take part in at least one mock trading session each month using all User IDs approved for Algo trading.**

**Steps for downloading files for participating in Futures & Options segment Mock Trading.**

- a) Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and password as being used in the live environment.

Download all the files kept in the DerivativesCOMMON\SETUP\Mock Setup folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.msei.in> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday, February 13, 2026, after Trading hours.

**b) Install VC++Redistributable 2008 on the system**

- c) Double click MSE-EDTWSCLIENT.msi. It will install the MSE-EDS Trader Workstation for mock Trading Version 11.6.24.0

- d) Double click MSE-EDSMEMADMIN.msi. It will install new MSE-EDS Member Administrator for mock Trading Version 11.6.24.0

- e) Following steps are to be followed by members after installation of TWS/ MAT

**i. For Leased Line mode of connectivity**

After installation start TWS / MAT and follow below mentioned steps:

- Go to Tools → System configuration
- Members need to select “**Dedicated**”.
- Members having bandwidth 2mbps or above needs to select Market Data Updates as “**HIGH**”. Other members need to select “**Normal**”
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the mock environment of MSE Futures & Options Market.

**ii. Internet users:**

**Kindly use the URL <https://trading.msei.in> for SSL VPN login.**

After installation start TWS and follow below mentioned steps:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the mock environment of MSE Futures & Options Market.
