In terms of provisions of the Rules, Bye-Laws & Regulations of the Exchange members may please note that Exchange will be conducting mock session in Capital Market Segment from Version 25 on Saturday, January 10, 2026, as per the following schedule:

Members may note that the trades resulting from such mock trading will not attract any margin obligation, pay-in and pay-out and do not create any rights and liability on members. Members are requested to participate actively in the Mock Trading Session.

Members with approved algorithmic software should take part in at least one mock trading session each month using all User IDs approved for Algo trading.

Members are requested to revert the connection settings to their previous configuration and use exiting sftp path for downloading Scrip.bcp for trading on Monday i.e. 12<sup>th</sup> January 2026 after completing the mock.

The use of new IPs on a permanent basis will be communicated at a later date.

**All CTCL Members are also advised to actively participate in the mock trading session from all trading software.**

**Steps for downloading files for participating in Capital Market segment Mock Trading.**

- a) Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and password as being used in the live environment.

Download **MAT, TWS** setup file kept in the **\SETUP\Version25\_Setup\TWS\_MAT\_Setup** folder and scrip.bcp file kept in **\SETUP\Version25\_Setup\ScripMaster** folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.msei.in> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday, January 09, 2026, after Trading hours.

**b) Install VC++Redistributable 2008 on the system**

- c) Double click **MSE-EQTWCLIENT.msi**. It will install the MSE-EQ Trader Workstation for mock Trading Version 25.0.4.0
- d) Double click **MSE-EQMEMADMIN.msi**. It will install new MSE-EQ Member Administrator for mock Trading Version 25.0.4.0
- e) Following steps are to be followed by members after installation of TWS/ MAT

**(i) For Leased Line mode of connectivity**

After installation start TWS / MAT and follow below mentioned steps:

- Go to Tools → System configuration
- Members need to select “**Dedicated**”.
- Members having bandwidth 2mbps or above needs to select Market Data Updates as “**HIGH**”. Other members need to select “**Normal**”
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the mock environment of MSE Capital Market.

**(ii) Internet users:**

Kindly use the URL <https://trading.msei.in> for SSL VPN login.

After installation start TWS and follow below mentioned steps:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the mock environment of MSE Capital Market.
