To All Members,

As a part of our continuous endeavor to enhance system performance and to further enhance the trading experience, Exchange will be implementing new version of trading software (MSE Member Admin Terminal 25.0.5.0 and MSE Trader Workstation 25.0.5.0) in Equity Capital Market with effect from Tuesday, January 27, 2026.

Members are requested to take note of the following.

- The new version of Members Terminals should be installed only after end of market hours on Friday, January 23, 2026, after completion of all daily activities such as online back-up, trade report, etc. for the day.
- Members may please note that this is a mandatory release of trading software and requested to install the new version to ensure uninterrupted trading from Tuesday, January 27, 2026.
- The new version can be downloaded from \SETUP\Version25_Setup\ folder available on SFTP (Extranet) <https://sftp.msei.in> for downloading through Internet to the members system.

Steps for downloading files for Equity Capital Market new version

- a) Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and password as being used in the production environment.

Download **MAT, TWS** setup file kept in the **\SETUP\Version25_Setup** folder and scrip.zip file kept in **Home \ScripMaster** folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.msei.in> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday, January 23, 2026, after Trading hours.

- b) **Install VC++Redistributable 2008 on the system**

- c) Double click **MSE-EQTWSCLIENT.msi**. It will install the MSE-EQ Trader Workstation for new TradingVersion 25.0.5.0
- d) Double click **MSE-EQMEMADMIN.msi**. It will install new MSE-EQ Member Administrator for new Trading Version 25.0.5.0

- e) Following steps are to be followed by members after installation of TWS/ MAT

(i) For Leased Line mode of connectivity

After installation start TWS / MAT and execute below-mentioned steps:

- Go to Tools → System Configuration
- Members need to select “**Dedicated**”.
- Members having bandwidth 2mbps or above needs to select Market Data Updates as “**HIGH**”. Other members need to select “**Normal**”
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the Equity Capital Market.

(ii) Internet users:

Kindly use the URL <https://trading.msei.in> for SSL VPN login.

After installation start TWS and execute the below-mentioned steps:

- Go to Tools → System Configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the Equity Capital Market.
