Pursuant to the provisions of SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 ("Master Circular") (Erstwhile SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023), trading in securities of M/s. Online Information Technologies Limited was suspended with effect from November 04, 2019 on account of non-compliance with Regulation 33 for the Quarters ended March 2019 & June 2019.
