Members may note that the trades resulting from such mock trading will not attract any margin obligation, pay-in and pay-out and do not create any rights and liability on members. Members are requested to participate actively in the Mock Trading Session.

Members having approved algorithmic software are required to mandatorily participate in mock trading sessions using all User Ids approved for Algo trading, irrespective of the algorithm having undergone change or not. Kindly refer to circular no. MCX-SX/CTCL/1477/2013 dated September 30, 2013. All Members are also advised to actively participate in the mock trading session to test the Connectivity, IRRR Platform and CTCL applications software.

Annexure

Steps for downloading files for participating in Capital Market segment Mock Trading.

- a) Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and password as being used in the live environment.

Download all the files kept in the \SETUP\Mock Setup folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.msei.in> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday May 08, 2026, after Trading hours.

- b) **Install VC++Redistributable 2008 on the system**

- c) Double click **MSE-EQTWSCLIENT.msi**. It will install the MSE-EQ Trader Workstation for mock Trading Version 25.0.5.0

- d) Double click **MSE-EQMEMADMIN.msi**. It will install new MSE-EQ Member Administrator for mock Trading Version 25.0.5.0

- e) Following steps are to be followed by members after installation of TWS/ MAT

(i) For Leased Line mode of connectivity

After installation start TWS / MAT and follow below mentioned steps:

- Go to Tools → System configuration
- Members need to select “**Dedicated**”.
- Members having bandwidth 2mbps or above needs to select Market Data Updates as “**HIGH**”. Other members need to select “**Normal**”
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the mock environment of MSE Capital Market.

(ii) Internet users:

Kindly use the URL <https://trading.msei.in> for SSL VPN login.

After installation start TWS and follow below mentioned steps:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the mock environment of MSE Capital Market.
