1 Purpose

This document outlines the Web API protocol for real-time communication between MSE and its Trading Members. It provides a standardized reference for developing and testing system interfaces on both the Exchange and its Members sides.

2 Scope

Bidirectional external interface APIs will be provided as REST endpoints accessible over internet using HTTPS protocol. All endpoints use JSON as the standard message format.

3 Target Audience

This document is designed for the trading members who need to submit their client information to MSE through exchange's API endpoints.

4 Messaging Protocols

- Messages or all request and response messages are in JSON (JavaScript Object Notation) format.
- All fields (including optional and reserved) mentioned in the respective API request format, must be present in request.
- A value could be Boolean (true/false), number, decimal, String or a structure (List or Object).
- All dates, times and date times are represented in Indian standard time.
- For date fields, format will be varied from API to API and the details will be provided on respective API.

5 Authorization

- The API consumer application is expected to send following headers (case-sensitive) in every API HTTPS request.
 - a. Token: A unique identifier generated for all successful logins.
- The API provider is not required to provide any header in its response.
- Token will have expiry of 30 minutes.

JWT mechanism is used to generate API authentication tokens as it is widely used industry standard.

6 API Endpoints

6.1 AUTHENTICATION API

6.1.1 API Description

This API is used to authenticate the user and provide a short life authentication token to use the subsequent API.

6.1.2 End-Point URL

Provide request body while calling this API as mentioned in the same request. The details should be same as the one-time user registration 'loginid' and 'password'. 'apiName' should be "ucc_auth".

6.2 UCC UPLOAD

6.2.1 API Description

This API is used to create a client information in the UCC system. It validates the client information provided before persisting to the system.

UCC Upload Request and Response Flow

Post successful Authentication using AUTHENTICATION API, member needs to first send the UCC data as per API message format 'UCC Upload Request Message'. The Exchange would perform header level validations and if any error is found, then response would be provided as per API message format 'UCC Upload Response Message-for Failure'. If header level is successfully validated, then response would be provided as per API message format 'UCC Upload Response Message-for Success' in which a 'requestNo' would be provided.

6.2.4 Threshold Limit

Initially API is limited to handle only 50 clients per request.

6.2.5 UCC Upload Request Message

Provide the token generated in Authentication API response in the Authorization header of this API along with request body.

Note: Strictly adhere to the following field level validation for smooth and high-performance throughput.

All the fields mentioned in the API message should be provided in the request. Even in the case of UCC modification, all the fields should be provided.
