To All Members,

In terms of provisions of the Rules, Bye-Laws & Regulations of the Exchange and with reference to circular no: MSE/TRD/18364/2025 dated December 26, 2025, MSE/TRD/18487/2026 dated January 19 2026, & MSE/TRD/19531/2026 dated August 10, 2026 regarding Modifications to the Pre-Open Auction Session Framework & MSE/TRD/19678/2026 September 03, 2026, regarding Update on Trading in Exchange Traded Funds (ETFs), members may please note that Exchange will be conducting Mock session in Capital Markets on Saturday, September 05, 2026, as per the following schedule:

Members having approved algorithmic software are required to mandatorily participate in mock trading sessions using all User Ids approved for Algo trading, irrespective of the algorithm having undergone change or not. Kindly refer to circular no. MCX-SX/CTCL/1477/2013 dated September 30, 2013. All Members are also advised to actively participate in the mock trading session to test the Connectivity and CTCL applications software.

All CTCL Members are also advised to actively participate in the mock trading session from all trading software.

Annexure 1

Steps for downloading files for participating in Capital Market segment Mock Trading.

- a) Members are advised to log-in to the Member Administrator Terminal (MAT) and Trader Workstation (TWS) with the user id and password as being used in the live environment.

Download **MAT**, **TWS** setup file kept in the \SETUP\Version25_Setup\TWS_MAT_Setup folder and scrip.bcp file kept in \SETUP\Version25_Setup\ScripMaster folder in the SFTP (Extranet) Server using address <https://192.168.125.209> for downloading through Lease Line and <https://sftp.mseindia.com> for downloading through Internet to the members system. Files can be downloaded any time through Internet or can be downloaded through Leased Line on Friday, September 04, 2026, after Trading hours.

b) Install VC++Redistributable 2008 on the system

- c) Double click **MSE-EQTWSCLIENT.msi**. It will install the MSE-EQ Trader Workstation for mock TradingVersion 25.0.9.0
- d) Double click **MSE-EQMEMADMIN.msi**. It will install new MSE-EQ Member Administrator for mock Trading Version 25.0.9.0

e) Following steps are to be followed by members after installation of TWS/ MAT

(i) For Leased Line mode of connectivity

After installation start TWS / MAT and follow below mentioned steps:

- Go to Tools → System configuration
- Members need to select “**Dedicated**”.
- Members having bandwidth 2mbps or above needs to select Market Data Updates as “**HIGH**”. Other members need to select “**Normal**”
- Click on Modify.
- System will set the configuration as entered / selected and TWS / MAT will be closed.
- Start TWS / MAT and login to the mock environment of MSE Capital Market.

(ii) Internet users:

Kindly use the URL <https://trading.msei.in> for SSL VPN login.

After installation start TWS and follow below mentioned steps:

- Go to Tools → System configuration
- Select Mode of Connectivity as “**Internet**”
- After selection click on Modify
- System will set the configuration as selected and TWS will be closed.
- Start TWS and login to the mock environment of MSE Capital Market.
