- 2. A MEMBER ENTITLED TO ATTEND AND VOTE AT THE ANNUAL GENERAL MEETING (THE MEETING) IS ENTITLED TO APPOINT PROXY/PROXIES TO ATTEND AND VOTE INSTEAD OF HIMSELF AND THE PROXY. THE PROXY NEED NOT BE A MEMBER OF THE COMPANY. The Board of Directors hereby presents its 32<sup>nd</sup> Director's Report on business and operations of the Company, along with Standalone Audited Financial Statements for the Financial Year ended on 31<sup>st</sup> March, 2017.

### 1. BACKGROUND

The Company is a Non Deposit Accepting Non-Banking Finance Company ("NBFC"), holding a Certificate of Registration (14.01006) from the Reserve Bank of India ("RBI").

### 2. STATE OF COMPANY'S AFFAIR

With the expected positive momentum in the Indian economy, the Company is focused on growth and achieving profitability along with a renewed commitment to enhance quality and customer service and to reduce costs. ### 3. FINANCIAL RESULTS



### 4. OPERATIONAL PERFORMANCE

During the period, the company earned total revenue of Rs. 168.21/- lakhs for the year ended 31st March, 2017 as against Rs. 254.45/- lakhs for the year ended 31st March, 2016. The Company suffered a loss of Rs. (11.39) /- lakhs during the year ended 31st March, 2017 as against loss of Rs. (10.67)/- lakhs in previous year ended 31st March, 2016.



### 5. DIVIDEND

The company is planning to expand and thereby would need funds to invest in future projects. Therefore the Company do not recommend any dividend but the directors are hopeful for better results in enduing future.

#### 6. RESERVES AND SURPLUS

As the Company has incurred loss during the Financial Year, no profits was transferred to Statutory Reserve Account for the Financial Year Ended 31st March 2017

### 7. SHARE CAPITAL

During the year under review, the share capital of the company remains unchanged and the company has also not issued any equity shares with differential rights and sweat equity shares.

### 8. LISTING OF SECURITIES

Earlier the Company got its shares listed with Delhi Stock Exchange Limited in the year 1990 when it came with Initial Public Offer inviting public to subscribe for its shares. The IPO of the Company was successful. Further Company got its shares listed with Metropolitan Stock Exchange of India Ltd. (formerly known as MCX Stock Exchange Limited) w.e.f 5<sup>th</sup> January, 2015 and now the company got its shares listed with BSE Ltd w.e.f 4<sup>th</sup>February 2016.

The Annual listing fees for the year 2016-17 have been paid to the Stock Exchange.

#### **NOTE - 1: SIGNIFICANT ACCOUNTING POLICIES**

# I. <u>Basis of preparation of financial statements:</u>

These financial statements have been prepared to comply with Accounting Principles Generally accepted in India (Indian GAAP), the Accounting Standards notified under the Companies (Accounting Standards) Rules, 2014 and the relevant provisions of the Companies Act, 2013. The financial statements are prepared on accrual basis under the historical cost convention. The financial statements are presented in Indian rupees.

#### II. Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities as at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively in current and future periods. The management believes that the estimates made in the preparation of the financial statements are prudent and reasonable

# III. <u>Income and Expenditure</u>

Income and Expenditure are accounted for on accrual basis except finance charges and interest on bad & doubtful debts which is recognized as per IRAC norms of RBI guidelines.

# IV. <u>Tangible Fixed Assets & Depreciation</u>

- a) Fixed Assets are stated at their original cost of acquisition inclusive of inward freight, duties and expenditure incurred in their acquisition, construction / installation.
- b) Depreciation is calculated on pro-rata basis from the date of additions, except in case of assets costing Rs. 5,000 or less, where each such asset is fully depreciated in the year of purchase. Depreciation on assets sold / discarded during the year is provided till the date of such sale / disposal.

#### V. <u>Investments</u>

Investment has been bifurcated into 'long term' and 'current' categories as per RBI Norms. Long term investment is valued at cost and current investment at cost or market value whichever is less. However, provision is being made where diminution in the value of long term investment other than temporary.

#### VI. INVENTORIES

Inventories of shares have been valued at cost.

### VII. LOANS & ADVANCES

Loans and Advances are classified in accordance with IRAC norms issued by RBI.

**VIII.** Dividend is accounted for as and when it is declared.

### IX. <u>Cash and cash equivalents</u>

Cash and cash equivalents for the purposes of cash flow statement comprise cash at bank and in hand and short term investments with an original maturity of three months or less

# X. <u>Provision, Contingent Liabilities and Contingent Assets:</u>

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources. Contingent

liabilities are not recognized but are disclosed in the notes. Contingent assets are neither recognized nor disclosed in the financial statements.

# a. Provision for Non-Performing Assets

Provision for standard and non-performing assets

- In accordance with Prudential Norms, contingent provision at 0.25% has been created on outstanding standard assets
- In accordance with Para 10 of Prudential Norms, the Company has shown provision for loans under 'Provisions' forming part of 'Current liabilities and provisions'


