

During this period, the Members of the Company, holding shares either in physical or dematerialized mode, as on the cut-off date i.e., Thursday, August 21, 2025 may cast their vote by remote e-voting. The remote e-voting module shall be disabled by CDSL for voting thereafter. Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently.

Mr. Mohit Parakh, Independent Director had been appointed by the Members at the 34th Annual General Meeting held on September 28, 2020 for a term of 5 (Five) consecutive years from July 30, 2020 till the conclusion of the 39th AGM of the Company. Based on rich experience, professional skill, knowledge, continued valuable guidance to the management and the contributions made by Mr. Parakh during his association with the Company and also on the basis of his performance evaluation, the Board of Directors of the Company has, on the recommendation of the Nomination and Remuneration Committee, considered it desirable that it shall be in the interest of the Company to continue to avail the services of Mr. Parakh, as an Independent Director of the Company.

Further, in the opinion of the Board, Mr. Parakh fulfils the conditions specified in the Act read with Schedule IV to the Act and Rules made thereunder and also under the Listing Regulations for re-appointment as an Independent Director of the Company. Mr. Mohit Parakh is independent of the Management of the Company. It is therefore proposed to re-appoint him as an Independent Director of the Company, to hold office for a second term of 5 (Five) consecutive years, commencing from the conclusion of this AGM till the 44th AGM of the Company, with a period of office not liable to retire by rotation. 

1. Background Information
