14. Voting through electronic means:

Pursuant to Section 108 of the Companies Act, 2013, and Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company is pleased to provide its members the facility to exercise their right to vote by electronic means.

The instructions for shareholders voting electronically are as under:

- (i) The voting period begins on 18th September, 2026 at 10.00 A.M. and ends on 22nd September, 2026 at 5.00 P.M.. During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of 16th September 2026 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/ retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants**. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

Step 1 : Access through Depositories CDSL/NSDL e-Voting system in case of individual shareholders holding shares in demat mode.

- (iv) In terms of **SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020** on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

DIRECTORS' REPORT**To the Members of CAPITAL FINVEST LIMITED**

Your Directors have pleasure in presenting the Forty Second Annual Report together with the audited financial statements for the financial year ended 31st March, 2026.

1. FINANCIAL RESULTS

The Financial statements of the Company have been prepared in accordance with the Indian Accounting Standards (Ind AS) notified under Section 133 of the Companies Act, 2013 ('the Act' read with Companies Accounts) Rules 2014. The financial statements for the financial year ended 31st March 2026 as well as comparative figures for the year ended 31st March 2025 are Ind As compliant.

2. FINANCIAL PERFORMANCE - OUTLOOK AND STATE OF AFFAIRS

During the year under review, your company has ensured business continuity. The company was engaged in investment activities in securities only during the year under review, hence the requirement of segment-wise reporting is considered not relevant. Your company is basically a investment company having no customer interface and not accessing any public funds as the company had always remained debt free. The Profit for the financial year under review was 7.46 lakhs as against loss of 3.55 lakhs for the previous financial year which is better in comparison with that of previous year. The profit before tax is 10.38 lakhs as against loss of 3.42 lakhs of last year. This is owing to the nature of the business of the company. Your company mainly operates in Capital Markets by way of arbitrage, trading and investment activities on its own account. The mainstay of your company's operations continued to be investments in various companies under which dividends flows into the company coupled with appreciation in capital and arbitrage income. The company is always on the lookout for alternative avenues for business opportunities. The company is managing various risks by maintaining a conservative financial profile and by following prudent business and risk management practices. We are careful with our portfolio quality. Company has significant quoted investments which are exposed to fluctuations in stock prices, which largely depend upon financial and capital markets. The redeeming feature is that the value of inventories has increased which will be utilized in coming years. Short and Medium term growth prospects look uncertain in view of war between IRAN and USA which has affected the entire Middle East and this has led to increase in crude prices affecting India very adversely. Further, USA's policy of tariffs remains uncertain. Inflation has emerged as a global challenge owing to the surge in energy prices, non-food commodities, input prices disruptions of global supply chains and rising freight costs etc. Tariffs have become a big and uncertain issue. Continued geopolitical tensions and extreme weather events present other downside risks to the outlook. All these factors affect the capital markets.

Investments here should always be a long term story but are always vulnerable to market risks. The management is optimistic about the future outlook of the company keeping a positive way forward.

There have been no material changes and commitments affecting the financial position of the Company which have occurred between the end of financial year and the date of this report.

Since the company does not have any public funds and customer interface, the Certificate of Registration granted by the RBI has been surrendered for cancellation, in view of the New Directions dated 29th April 2026 on NBFC's issued by the RBI. This does not affect the company's business in any way. Thus leading to lesser compliances.

3. DIVIDEND

Your Directors do not recommend any dividend for the year ended 31st March, 2026 due to meagerness of the profit.

4. TRANSFER TO RESERVES

The company has transferred an amount of Rs. 1,50,000/- to the Statutory Reserve Fund under section 451C of the RBI Act for the Financial Year 2025-2026 out of Profit and Loss Account for the year.

5. CHANGE IN THE NATURE OF BUSINESS

There has been no change in the nature of the business of the Company.

6. SUBSIDIARY COMPANIES

The Company did not have any Subsidiary Company or any joint ventures during the year under review.

ANNEXURE - II REMUNERATION POLICY

Remuneration Policy for Directors, Key Managerial Personnel and other employees

This remuneration policy has been prepared pursuant to the provisions of Section 178(3) of the Companies Act, 2013 and Clause 49 of the Listing Agreement. In case of any inconsistency between the provisions of law and this remuneration policy, the provisions of law shall prevail and the company shall abide by the applicable law.

Key principles governing this remuneration policy are as follows:

Remuneration for Independent Directors

In addition to the sitting fees, they are also eligible for out of pocket expenses incurred for attending the Board Meetings and Committees of the Board.
- » Overall remuneration (sitting fees) should be fair and reasonable keeping in view the nature and size of the company's activities.

Remuneration for Managing Director (MD) / Whole Time Director / KMP/ Rest of the employees

The extent of overall remuneration should be sufficient to engage and retain suitable individuals. Hence remuneration should be based on:

- » Qualification, experience and suitability to the company,
- » Market competitiveness,
- » Driven by the role played by the individual,
- » Reflective of size of the Company, complexity of the sector / industry / company's operations and the company's capacity to pay.
- » The remuneration mix for the MD / EDs or Wholetime Director is as per the terms approved by the Board and Members. In case of any change, the same would require the approval of the Members.
- » Basic / fixed salary is provided to all employees as per terms agreed with them.
- » In addition to the basic / fixed salary, the company may provide employees with certain perquisites, allowances and benefits where possible like leave encashment, bonus, reimbursement etc. and annual increments.
- » In addition to the fixed salary and perquisites as provided, the company may provide MD / EDs or Wholetime director such remuneration, calculated with reference to the net profits of the company in a particular financial year, as may be determined by the Board, subject to the overall ceiling stipulated in Section 197 of the Act.

Policy implementation

The NRC is responsible for recommending the remuneration policy to the Board. The Board is responsible for approving and overseeing implementation of the remuneration policy.

1. Opinion

NOTES TO THE FINANCIAL STATEMENTS AS AT 31ST MARCH, 2026**1 Corporate information**

The company is mainly dealing in stocks, securities and commodities. The Company does not have any subsidiary or holding company.

2 Significant accounting policies**(1) Basis of preparation of financial statements**

These standalone financial statements have been prepared in accordance with Indian Accounting Standards ("IndAS") notified under section 133 of the Companies Act 2013 ("the Act"), read with the Companies (Indian Accounting Standards) Rules, 2015 as amended under the Companies Act 2013 and under the historical cost convention on the accrual basis except for certain financial instruments which are measured at fair values, and on the basis of accounting principle of a going concern in accordance with generally accepted accounting principal (GAAP). Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use. The financial statements are presented in Lakhs or decimal thereof unless otherwise specified.

(2) Revenue from operations**Interest Income**

- a) Under IndAS 109, Interest income is recognised by applying the Effective Interest Rate (EIR) to the gross carrying amount of financial assets other than credit-impaired assets and financial assets classified as measured at fair value through Profit and loss (FVTPL).

(3) Dividend Income

Dividend income is recognised when it is actually received

- a. When the right to receive the payment is established.
- b. it is probable that the economic benefits associated with the dividend will flow to the entity and
- c. the amount of the dividend can be measured reliably"

(4) Taxes**Current tax**

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates and laws that are enacted or substantively enacted at the Balance sheet date.

Current income taxes are recognized in profit or loss except to the extent that the tax relates to items recognized outside profit or loss, either in other comprehensive income or directly in equity. Management periodically evaluates position taken in the tax returns with respect to situations in which applicable tax regulations are subjected to interpretation and establishes provisions, where appropriate.

(5) Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit.

(6) Property, plant and equipment

Property, plant and equipment are stated at cost, net of recoverable taxes, trade discount and rebates less accumulated depreciation and impairment loss, if any. Such cost includes purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for its intended use, net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the assets.

Depreciation

Depreciation is calculated as per the estimated useful life of assets prescribed by the Schedule II to the Companies Act 2013.

Derecognition of assets

An item of property plant & equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset is included in the income statement when the asset is derecognised.

- (7) Trade Investments are the investments made to enhance the Company's business interests. All other investments other than trade investments are either classified as current or long-term, based on Management's intention at the time of purchase. Current investments are valued at lower of cost or Net Realised Value / Market Value Categorywise. Long term investments are valued at cost less permanent diminution, if any, of each investment.

(8) Intangible assets

Intangible Assets are stated at cost of acquisition net of recoverable taxes less accumulated amortisation and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use and net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the intangible assets.

Derecognition of assets

An item of intangible asset and any significant part initially recognized is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset is included in the income statement when the asset is derecognized.

- (9) Contingent Liabilities, if any are not provided for in the accounts and are shown separately in Notes on Accounts.
- (10) Under the previous Gaap, non-current investments were stated at cost or NRV whichever is lower where applicable, provision was made to recognise a decline, other than temporary, in valuation of such investments. Under IndAS, equity instrument [other than investment in subsidiaries, joint ventures and associates] have been classified as Fair Value through Profit /Loss(Retained Earnings) through an irrevocable election at the date of transition. Further, under previous GAAP, joint ventures were consolidated using 'proportionate consolidation' method. Under IndAS, joint ventures have been accounted using 'equity method'

- 3 Accounting Policies not specifically referred to or otherwise are consistent and in consonance with generally accepted accounting principles keeping in view IND-AS.
- 4 The Financial Statements have been prepared as per schedule III; Division III of the Companies Act 2013 following Companies (Indian Accounting Standard) Rules 2015 on NBFC. The company has adopted Indian Accounting Standards (IND-AS) with effect from 1st April 2019 and effective date of such transition is 1st April 2018. The results have been prepared in accordance with the Companies (Indian Accounting Standard) Rule, 2015 (Ind As) prescribed under section 133 of the Companies Act 2013 and other recognised accounting practices and policies to the extent applicable.
