

And thereafter was affecting trades and transaction over the Internet under the MSEI Currency Segment.

CASE OF THE APPLICANT.

The Applicant was delivered from time to time, Trading Account, Trade confirmation, Margin statements and Daily activity statement, Contract Notes/Bills, for all the Transactions executed by him, receipts thereof were never been disputed by him. The Applicant was also appraised through SMS Alerts of Requirements of Margin and shortfalls prevail in his Trading Account.
- 3. Last transaction was carried out by the Applicant on 24th August, 2015.
- 4. As a result of Transaction executed and carried out by the Applicant, a Debit of Rs. 122,770.72 aroused in the Account of the Respondent.
- 5. The Respondent had not responded to the repeated requests and reminders and legal Notice by the Applicant, to clear his outstanding debit balance.

CASE OF RESPONDENT.

6. None appeared for and on behalf of the Respondent, nor written statement was submitted by him.

OBSERVATIONS AND CONCLUSIONS.

7. The Respondent had carried out transactions as covered under Rules, Byelaws and Regulations of the MSEIL and the amount of Rs. 122,770.72 remained due and payable by the Respondent to the Applicant in respect of the said Transactions.
